### VISIONARY SCHOLARSHIP PROGRAM

The mission of the Art Alliance for Contemporary Glass (AACG) is to further the development and appreciation of art made from glass. AACG has established a Visionary Scholarship Program for individual artists seeking to pursue a career in glass.

These scholarships are publicized as the Art Alliance of Contemporary Glass Visionary Scholarship Program. It may cover a part or all of the funds requested. The scholarship check will be sent directly to the school contact person.

**WE INVITE YOU TO SELECT UP TO TWO (2) APPLICANTS FOR THIS SCHOLARSHIP AWARD. ALL APPLICATIONS ARE DUE NOT LATER THAN APRIL 15, 2019 FOR COURSES TO COMMENCE JUNE 1, 2019 OR AFTER.**

The AACG Visionary committee expects the school to use the following criteria for all awards:

#### THE **APPLICANT** MUST:

- A. Be recommended by the school or a qualified glass instructor.
- B. Be seeking a career in art using the medium of glass.
- C. Submit the **Recipient Evaluation of Scholarship Program** form **within thirty (30) days after the course ends.**

#### THE **SCHOOL** MUST:

- A. **Submit all required forms and images in a single pdf format by April 15, 2019 deadline:**
  - **Scholarship Application** form
    - Recommend applicants based on his/her need, merit and reputation.
    - Recommend applicants who live and work in the United States.
  - Minimum of two (2) or maximum of four (4) images of Artist's work.
  - Provide the Artist's current biography.
  - IRS Federal Tax Exemption Certificate.
- B. **Submit After Course Ends:**
  - **School Evaluation of Scholarship Recipient** form
  - **Acknowledgement** of use of funds form

Complete the form in its entirety and submit by clicking on the green **EMAIL** button located on the form itself.”

Email at least two (2) images of the Artist's work, the Artist's current biography and the IRS Federal Tax Exemption Certificate **in a single pdf format only**, to [AACGvisionary@contempglass.org](mailto:AACGvisionary@contempglass.org) by the April 15, 2019 deadline.
